**Request for Proposals**

**PLEASE TAKE NOTICE** that the Lakewood Township Municipal Utilities Authority (Authority) hereby solicits proposals for **the installation of a sewer solids grinder at the County Line Manor Sewage Lift Station.**

**Sealed proposals must be submitted to the Executive Director on or before March 17, 2017 at 10:00a.m. Sealed proposals may be submitted in person at the Authority's office located at 390 New Hampshire Ave., Lakewood, NJ, or sealed proposals may be mailed in advance to the attention of Justin Flancaum, Executive Director, 390 New Hampshire Ave., Lakewood, NJ 08701. All proposals must be contained in a sealed envelope with the name and address of the party submitting the proposal and marked "sealed proposal."**

Proposals for the below listed services are being solicited through a fair and open process in accordance with N.J.S.A.19:44A-20.5 et. seq. The following criteria will be used in the awarding of contracts for services:

1. Experience and knowledge in the field.
2. Availability to attend any meetings of the LTMUA and to service the needs of the Authority as requested by the Commissioners, Executive Director and staff.
3. Compensation proposal.
4. Any other factors deemed to be in the best interest of the Authority as detailed in the scope of services below.

In addition, the LTMUA reserves the right to consider the following other factors:

1. Does the vendor's proposal indicate a clear understanding of the scope of work and related objectives?
2. Is the vendor's proposal complete and responsive to the public notice and specifications?
3. Does the vendor have a record of honesty and moral integrity?
4. Does the vendor have a record of reliability?
5. Vendor's past performance to the Authority, and willingness to document same.
6. Vendor's past performance of similar services, and willingness to document same.
7. Does the vendor have an experienced, qualified staff to assist him in completing the Authority's assignments?
8. Are the vendor's resources, i.e. personnel, facilities etc. in reasonable proximity to Lakewood, New Jersey?

9. Will the vendor provide a timely, fully explained billing for his goods/services, including a comprehensive breakdown of specific tasks?
10. Is the vendor financially stable and strong?

**Scope of Work:**

Objective:

To re-deploy a sewer solids grinder that operates on 240 VAC 3 PH power to a site that utilizes 240 VAC single phase power.

- Re-install the modified frame at the Authority's County Line Road Lift station's wet well.
- Supply, install and wire a NEMA 3R Enclosure and VFD controller with an auto reverse function. Recommended or equivalent VFD should be as follows:

Yaskawa brand 5 HP, 240 VAC single phase input, 230 VAC 3- Phase output full load current of 54 amps. A1000 Series Solid state Pulse Width Modulated Frequency Drive System suitable for operating a 230 VAC induction motor for use with a CONSTANT torque load.

This will include:

1. #A1C6A054PCH w/NEMA 3R enclosure.
2. Proper main MCCB for single phase 240 VAC Supply Power.
3. Output 3% load reactor.
4. Suitable for 4-20 mADC remote signal input/output.
5. Door mounted controls to include:
  - A. Enhanced LED/LCD VFD keypad and memory
  - B. Hand/OFF/AUTO selectable keypad.
  - C. Speed potentiometer.

**Additional Requirements:**

- Contractor must be licensed and insured in the State of NJ
- A Disclosure of Investment activities in Iran must be completed and submitted together with the proposal
- A current NJ Business Registration Certificate must be submitted together with the proposal
- Contractor must be registered as a State of NJ Public works Contractor. Current registration must be submitted together with the proposal
- Contractor must be in full compliance with the New Jersey Prevailing Wage Act (N.J.S.A. 34:11-56.26 et. seq.)

- Contractor must be registered with the NJ Division of Wage and Hour Compliance as required by the Public Works Contractor Registration Act (PWCRA) P.L. 1999, c.238 N.J.S.A. 34:11-56.48 et seq.
- In accordance with N.J.A.C. 12:60-2.1 and 6.1 of the New Jersey Prevailing Wage Act (N.J.S.A. 34:11-56.25 et. seq.) certified payroll reports must be submitted to the Authority, by all contractors and subcontractors, for each employee on the project within ten (10) days of the payment of wages.
