NOTICE IS HEREBY GIVEN THAT SEALED BIDS ENTITLED:

"POTABLE WATER SUPPLY WELL #3 REDEVELOPMENT" will be received by Lakewood Township Municipal Utilities Authority (herein after called the Owner or the LTMUA) at the offices located at 390 New Hampshire Avenue, Lakewood, New Jersey 08701 (732) 363-4422 at 11:00 AM prevailing time on Thursday, January 30, 2025 and will be publicly opened and read aloud. Deviation from this submittal procedure will subject the proposal to rejection.

The work of this Contract includes, but is not necessarily limited to the following:

In general, the work will include furnishing of all labor, materials and equipment necessary to complete the Potable Water Supply Well #3 Redevelopment. The well has had the motor removed to a motor repair shop and the existing column pipe, lineshafting and vertical turbine pump have also been removed for disposal. The redevelopment work for the aforementioned well will include but not limited to, high pressure jetting, swabbing, column, lineshaft & pump replacement with water lubricated vertical turbine pumps rated for 400 GPM @ 572' TDH and installed 400 feet deep. Work includes well pump 75 horsepower motor repairs that include cleaning and reinsulating of windings, installation of new bearings, reassembly and testing. The discharge head is to be refurbished. New motor shaft and top shaft to be provided. Well to be performance tested and the contractor shall be required to complete all other associated work to complete the intent of this project as specified herein.

Each Proposal must be submitted utilizing the forms contained within the Contract Documents. It must be enclosed in a sealed envelope bearing on the outside the name of the **BIDDER**, his address and name of Project(s) for which the Bid is submitted. Materials to be contained within the sealed envelope are specified under "Instructions to Bidders." Bid Proposals shall be complete, in ink, and any Bids incomplete or not submitted in a sealed, specially addressed envelope may be considered informal.

are additional and variable depending upon the pick-up or delivery option selected by the purchaser. Bid documents cannot be obtained at the Owner's or at the engineer's, Van Cleef Engineering Associate's, office. The printing costs not refundable.

Each Bid must be accompanied by a proposal guarantee in the form of a Bid Bond or Certified Check for an amount equal to ten percent (10%) of the full amount of each Contract Bid, not to exceed \$20,000. Surety shall be made payable to: **Lakewood Township Municipal Utilities Authority**, and shall be without condition or qualification.

All Bidders shall be required to comply with **Chapter 127, P.L. 1975, c. 127**, requiring each Bidder and each Subcontractor to formulate and submit to the proper authorized representative of the State of New Jersey an Affirmative Action Program of equal opportunity which guarantees minorities employment in all categories.

Bidders are required to comply with the requirements of P.L. 1975, c.127 (N.J.A.C. 17:27-1 et. seq.) and N.J.S.A. 10:5-31 et. seq.

All bidders must comply with the Prevailing Wage Act, N.J.S.A. 34:11-56.25 et seq. and the N.J.S.A. 34:1B-5.1, Chapter 150 Laws of 1963.

If the Bidder is a Corporation or a Partnership, the Bidder, in conformance with **Chapter 33, P.L. 1977**, shall submit with his Bid, a statement setting forth the names and addresses of all stockholders who own a **10 percent** or greater interest in the firm.

The Borough reserves the right to waive any informalities or to reject any and all Bids, if it is in the public interest to do so.
