NOTICE IS HEREBY GIVEN THAT SEALED BIDS ENTITLED:

"POTABLE WATER SUPPLY WELL NO. 1 REDEVELOPMENT" will be received by Lakewood Township Municipal Utilities Authority (herein after called the Owner or the LTMUA) at the offices located at 390 New Hampshire Avenue, Lakewood, New Jersey 08701 (732) 363-4422 at **11:00 AM** prevailing time on **Tuesday, September 22, 2026** and will be publicly opened and read aloud. Deviation from this submittal procedure will subject the proposal to rejection.

The work of this Contract includes, but is not necessarily limited to the following:

In general, the work will include furnishing of all labor, materials and equipment necessary to complete the Potable Water Supply Well #1 Redevelopment. The redevelopment work for the aforementioned well will include but not be limited to, initial pump test, removal and disposal of existing submersible pump, column piping and appurtenances, pre-redevelopment CCTV and inspection, vertical alignment and plumbness test, mechanical cleaning, chemical treatment, post-redevelopment CCTV, post-redevelopment pump test, and furnish & installation of new epoxy coated 6" Sch 40 steel, threaded column pipe, pump, motor, shafts, discharge head, and all associated appurtenances. The new vertical turbine pump shall be water lubricated and be rated for 400 GPM at 523' TDH and installed 400 feet deep. The motor shall be rated for 75 horsepower. Well to be performance tested, chlorinated and bacteria tested prior to returning to service and the contractor shall be required to complete all other associated work to complete the intent of this project as specified herein.

Each Proposal must be submitted utilizing the forms contained within the Contract Documents. It must be enclosed in a sealed envelope bearing on the outside the name of the **BIDDER**, his address and name of Project(s) for which the Bid is submitted. Materials to be contained within the sealed envelope are specified under "Instructions to Bidders." Bid Proposals shall be complete, in ink, and any Bids incomplete or not submitted in a sealed, specially addressed envelope may be considered informal.

Contract Documents may be obtained on or after **September 4, 2026** and reviewed online at no cost at **www.bidset.com/vancleef**. The Contract Documents may be obtained by any prospective bidder upon payment of a fee for each set of full-sized drawings with specifications by calling **1-877-424-3738** or by online request. Shipping charges are additional and variable depending upon the pick-up or delivery option selected by the purchaser. Bid documents cannot be obtained at the Owner's or at the engineer's, Van Cleef Engineering Associate's, office. The printing costs not refundable.

Each Bid must be accompanied by a proposal guarantee in the form of a Bid Bond or Certified Check for an amount equal to ten percent (10%) of the full amount of each Contract Bid, not to exceed \$20,000. Surety shall be made payable to: **Lakewood Township Municipal Utilities Authority**, and shall be without condition or qualification.

All Bidders shall be required to comply with **Chapter 127, P.L. 1975, c. 127**, requiring each Bidder and each Subcontractor to formulate and submit to the proper authorized representative of the State of New Jersey an Affirmative Action Program of equal opportunity which guarantees minorities employment in all categories.

Bidders are required to comply with the requirements of P.L. 1975, c.127 (N.J.A.C. 17:27-1 et. seq.) and N.J.S.A. 10:5-31 et. seq.

All bidders must comply with the Prevailing Wage Act, N.J.S.A. 34:11-56.25 et seq. and the N.J.S.A. 34:1B-5.1, Chapter 150 Laws of 1963.

If the Bidder is a Corporation or a Partnership, the Bidder, in conformance with **Chapter 33, P.L. 1977**, shall submit with his Bid, a statement setting forth the names and addresses of all stockholders who own a **10 percent** or greater interest in the firm.

The Authority reserves the right to waive any informalities or to reject any and all Bids, if it is in the public interest to do so.
