LAKEWOOD TOWNSHIP MUNICIPAL UTILITIES AUTHORITY JOB DESCRIPTION T-1 LICENSE OPERATOR

The individual in this position must possess a NJDEP T-1 license, and will be responsible to perform work activities associated with the treatment of public potable water, working on the water distribution system along with its appurtenances and the operation and maintenance of sewer lift stations, piping and appurtenances. The general work activities are plant operations, which involve water treatment theory / practice, plant equipment operation, maintenance, and repair, operation, maintenance, and repair of water distribution system, and monitoring the proper operation of sewer lift stations and associated equipment.

ESSENTIAL FUNCTIONS

- Must be able to work in all weather conditions both indoors and outdoors.
- Position is normally M-F 8:308:00are to 4:30pm but requires a minimum of one 7 day on call availability work week a month (additional compensation will be paid for on call).
- Individual must be able to climb ladders and water tanks to a maximum of 30 feet.
- Must be able to lift up to 75 lbs.
- Responsible in the operation and maintenance of sewer lift stations.
- Assist with annual hydrant flushing.
- Produce potable water in accordance with all state and federal regulations.
- Understand water treatment theory / technology and apply that knowledge to the water treatment process / production.

- Monitoring of gauges, flow meters, charts, system control computer, etc. and the installation and removal of same.
- Conducting water analysis test such as iron, chlorine residual, PH, etc.
- Maintain treatment records in accordance with LTMUA, state and federal regulations.
- Monitoring and reporting to supervision in order to insure a proper supply of chemicals and supplies are on hand.
- Performs routine preventive maintenance on plant equipment to include: adjustments and calibrations on equipment, basic mechanical, plumbing and electrical work, cleaning, lubricating and replacing equipment parts.
- Must be familiar with SCADA systems and their use in addition to performing basic troubleshooting and maintenance with the system. Well rounded in the use of personal computers.
- Ability to communicate with customer's when performing work orders in homes or businesses.
- Must be familiar with meter installations
- Work in and around raw sewage/wastewater.
- Work in and around underground utilities.
- Manual digging and excavating
- Assisting other employees in performing repairs/maintenance of water/wastewater pipelines and other facilities.
- Clean and maintain equipment used in the course of work.
- Fill out accurate work orders and track parts usage.
- Work cooperatively with other employees and the public.
- Operate pick-up trucks and other company vehicles
- Follow all Authority safety policies
- Perform other related duties as required.
